**AFFIDAVIT OF CONSTRUCTION COSTS

 WITHIN THE SWINOMISH INDIAN RESERVATION**

Section 14-01.340 of the Swinomish Tribal Code establishes Tribal Employment Rights (TERO) fees for constructions projects within the Swinomish Indian Reservation. For all construction projects permitted through the Swinomish Planning and Community Development Department, these TERO fees will be assessed on the total gross project cost per Section 14-01.340, as indicated in the table below. This affidavit serves to document the gross cost of the project for construction under the below indicated permit.
